Measurement General Outcome: Develop spatial sense and proportional reasoning.	
Specific Outcome: Solve problems that involve linear measurement, using: <ul style="list-style-type: none"> • SI and imperial units of measure • estimation strategies • measurement strategies. [ME, PS, V]	
Provide referents for linear measurements, including millimetre, centimetre, metre, kilometre, inch, foot, yard and mile, and explain the choices.	MC #4, Conceptual

Estimate a linear measure, using a referent, and explain the process used.	
Justify the choice of units used for determining a measurement in a problem-solving context.

Sketch a diagram to represent a problem that involves surface area or volume.	
Determine the surface area of a right cone, right cylinder, right prism, right pyramid or sphere, using an object or its labelled diagram.	MC #54, Procedural WR #1d), Procedural

<p>Specific Outcome: Develop and apply the primary trigonometric ratios (sine, cosine, tangent) to solve problems that involve right triangles.</p> <p>[C, CN, PS, R, T, V]</p>	
Explain the relationships between similar right triangles and the definitions of the primary trigonometric ratios.	MC #14, Procedural

Algebra and Number

Specific Outcome: Demonstrate an understanding of factors of whole numbers by determining the:	
<ul style="list-style-type: none"> • prime factors • greatest common factor • least common multiple • square root • cube root.

Determine the prime factors of a whole number.	
Explain why the numbers 0 and 1 have no prime factors.	
Determine, using a variety of strategies, the greatest common factor or least common multiple of a set of whole numbers, and explain the process.	MC #36, Procedural
Determine, concretely, whether a given whole number is a perfect square, a perfect cube or neither.	
Determine, using a variety of strategies, the square root of a perfect square, and explain the process.	MC #16, Procedural
Determine, using a variety of strategies, the cube root of a perfect cube, and explain the process.	
Solve problems that involve prime factors, greatest common factors, least common multiples, square roots or cube roots.	NR #57, Conceptual NR #58, Procedural
Specific Outcome: Demonstrate an understanding of irrational numbers by:	
<ul style="list-style-type: none"> • representing, identifying and simplifying irrational numbers • ordering irrational numbers.

Sort a set of numbers into rational and irrational numbers.	MC #31, Conceptual
Determine an approximate value of a given irrational number.	MC #32, Conceptual
Approximate the locations of irrational numbers on a number line, using a variety of strategies, and explain the reasoning.	
Order a set of irrational numbers on a number line.	
Express a radical as a mixed radical in simplest form (limited to numerical radicands).	
Express a mixed radical as an entire radical (limited to numerical radicands).	
Explain, using examples, the meaning of the index of a radical.	
Represent, using a graphic organizer, the relationship among the subsets of the real numbers (natural, whole, integer, rational, irrational).	
Specific Outcome: Demonstrate an understanding of powers with integral and rational exponents.

Explain, using patterns, why $a^{-n} = \frac{1}{a^n}$, $a \neq 0$.	

Explain, using patterns, why $a^{\frac{1}{n}} = \sqrt[n]{a}$, $n > 0$.	
Apply the exponent laws: <ul style="list-style-type: none"> • $(a^m)(a^n) = a^{m+n}$ • $(a^m) \div (a^n) = a^{m-n}$, $a \neq 0$ • $(a^m)^n = a^{mn}$ • $(ab)^m = a^m b^m$ • $\left(\frac{a}{b}\right)^n = \frac{a^n}{b^n}$, $b \neq 0$ to expressions with rational and variable bases and integral and rational exponents, and explain the reasoning.	
Express powers with rational exponents as radicals and vice versa.

Identify and correct errors in a simplification of an expression that involves powers.	
Specific Outcome: Demonstrate an understanding of the multiplication of polynomial expressions (limited to monomials, binomials and trinomials), concretely, pictorially and symbolically. [CN, R, V]	
<i>(It is intended that the emphasis of this outcome be on binomial by binomial multiplication, with extension to polynomial by polynomial to establish a general pattern for multiplication.)</i> Model the multiplication of two given binomials, concretely or pictorially, and record the process symbolically.	
Relate the multiplication of two binomial expressions to an area model.	
Explain, using examples, the relationship between the multiplication of binomials and the multiplication of two-digit numbers.	MC #33, Conceptual
Verify a polynomial product by substituting numbers for the variables.	NR #19, Procedural

Identify and explain errors in a solution for a polynomial multiplication.	
Specific Outcome: Demonstrate an understanding of common factors and trinomial factoring, concretely, pictorially and symbolically. [C, CN, R, V]	
Determine the common factors in the terms of a polynomial, and express the polynomial in factored form.	
Model the factoring of a trinomial, concretely or pictorially, and record the process symbolically.	

Factor a polynomial that is a difference of squares, and explain why it is a special case of trinomial factoring where $b = 0$.	
Identify and explain errors in a polynomial factorization.	
Factor a polynomial, and verify by multiplying the factors.	MC #37, Procedural
Explain, using examples, the relationship between multiplication and factoring of polynomials.	
Generalize and explain strategies used to factor a trinomial.	
Express a polynomial as a product of its factors.	
Relations and Functions	
General Outcome: Develop algebraic and graphical reasoning through the study of relations.	
Specific Outcome: Interpret and explain the relationships among data, graphs and situations. [C, CN, R, T, V]	
Graph, with or without technology, a set of data, and determine the restrictions on the domain and range.	MC #29, Conceptual MC #30, Conceptual
Explain why data points should or should not be connected on the graph for a situation.	MC #46, Procedural

Determine, and express in a variety of ways, the domain and range of a graph, a set of ordered pairs or a table of values.	
Specific Outcome: Demonstrate an understanding of relations and functions. [C, R, V]	
Explain, using examples, why some relations are not functions but all functions are relations.	
Determine if a set of ordered pairs represents a function.	
Sort a set of graphs as functions or non-functions.	
Generalize and explain rules for determining whether graphs and sets of ordered pairs represent functions.	
Specific Outcome: Demonstrate an understanding of slope with respect to: • rise and run • line segments and lines • rate of change • parallel lines • perpendicular lines. [PS, R, V]	
Determine the slope of a line segment by measuring or calculating the rise and run.	NR #7, Procedural MC #45, Procedural
Classify lines in a given set as having positive or negative slopes.	MC #55, Conceptual

Explain the meaning of the slope of a horizontal or vertical line.	
Explain why the slope of a line can be determined by using any two points on that line.	
Explain, using examples, slope as a rate of change.	
Draw a line, given its slope and a point on the line.	
Determine another point on a line, given the slope and a point on the line.	
Generalize and apply a rule for determining whether two lines are parallel or perpendicular.	
Solve a contextual problem involving slope.	
Specific Outcome: Describe and represent linear relations, using: <ul style="list-style-type: none"> • words • ordered pairs • tables of values • graphs • equations. [C, CN, R, V]	
Identify independent and dependent variables in a given context.	
Determine whether a situation represents a linear relation, and explain why or why not.	
Determine whether a graph represents a linear relation, and explain why or why not.	
Determine whether a table of values or a set of ordered pairs represents a linear relation, and explain why or why not.	
Draw a graph from a set of ordered pairs within a given situation, and determine whether the relationship between the variables is linear.	
Determine whether an equation represents a linear relation, and explain why or why not.	
Match corresponding representations of linear relations.	
Specific Outcome: Determine the characteristics of the graphs of linear relations, including the: <ul style="list-style-type: none"> • intercepts • slope • domain • range. [CN, PS, R, V]	
Determine the intercepts of the graph of a linear relation, and state the intercepts as values or ordered pairs.	MC #51, Conceptual
Determine the slope of the graph of a linear relation.	MC #47, Conceptual
Determine the domain and range of the graph of a linear relation.	MC #26, Conceptual
Sketch a linear relation that has one intercept, two intercepts or an infinite number of intercepts.	

Identify the graph that corresponds to a given slope and y -intercept.	
Identify the slope and y -intercept that correspond to a given graph.	
Solve a contextual problem that involves intercepts, slope, domain or range of a linear relation.	MC #24, Conceptual MC #44, Conceptual

Express a linear relation in different forms, and compare the graphs.	
Rewrite a linear relation in either slope–intercept or general form.	MC #41, Procedural
Generalize and explain strategies for graphing a linear relation in slope–intercept, general or slope–point form.	
Graph, with and without technology, a linear relation given in slope–intercept, general or slope–point form, and explain the strategy used to create the graph.	
Identify equivalent linear relations from a set of linear relations.	
Match a set of linear relations to their graphs.	
<p>Specific Outcome: Determine the equation of a linear relation, given:</p> <ul style="list-style-type: none"> • a graph • a point and the slope • two points • a point and the equation of a parallel or perpendicular line <p>to solve problems. [CN, PS, R, V]</p>	
Determine the slope and y -intercept of a given linear relation from its graph, and write the equation in the form $y = mx + b$.	
Write the equation of a linear relation, given its slope and the coordinates of a point on the line, and explain the reasoning.	
Write the equation of a linear relation, given the coordinates of two points on the line, and explain the reasoning.	
Write the equation of a linear relation, given the coordinates of a point on the line and the equation of a parallel or perpendicular line, and explain the reasoning.	MC #21, Conceptual MC #22, Conceptual MC #40, Procedural
Graph linear data generated from a context, and write the equation of the resulting line.

Express the equation of a linear function in two variables, using function notation.	
Express an equation given in function notation as a linear function in two variables.	
Determine the related range value, given a domain value for a linear function; e.g., if $f(x) = 3x - 2$, determine $f(-1)$.	MC #52, Conceptual
Determine the related domain value, given a range value for a linear function; e.g., if $g(t) = 7 + t$, determine t so that $g(t) = 15$.	NR #17, Procedural MC #52, Conceptual
Sketch the graph of a linear function expressed in function notation.	
Specific Outcome: Solve problems that involve systems of linear equations in two variables, graphically and algebraically. [CN, PS, R, T, V]	
Model a situation, using a system of linear equations.	MC #60, Procedural
Relate a system of linear equations to the context of a problem.	
Determine and verify the solution of a system of linear equations graphically, with and without technology.	MC #59, Conceptual WR #3e), Procedural
Explain the meaning of the point of intersection of a system of linear equations.	
Determine and verify the solution of a system of linear equations algebraically.	WR #3e), Procedural
Explain, using examples, why a system of equations may have no solution, one solution or an infinite number of solutions.	
Explain a strategy to solve a system of linear equations.	
Solve a problem that involves a system of linear equations.	MC #43, Conceptual
